Notice to Unitholders of Manulife Funds Manulife SGD Income Fund (the "Sub-Fund")

Dear Valued Unitholder

CHANGE IN DISTRIBUTION FREQUENCY AND REDESIGNATION OF THE DISTRIBUTION CLASSES OF UNITS AND DECUMULATION CLASSES OF UNITS OF THE SUB-FUND

We, Manulife Investment Management (Singapore) Pte. Ltd., as the manager of the Sub-Fund, would like to inform you that with effect from **8 January 2024**, the distribution frequency for the distribution classes of units and the decumulation classes of units of the Sub-Fund will be changed from a quarterly to a monthly basis.

We understand the importance of providing a steady and more frequent income stream to meet investors' expectations and demand. This adjustment in our distribution strategy for the Sub-Fund reflects our commitment to meeting the evolving needs and preferences of our valued investors.

With the change in distribution frequency, it is currently intended that the first record date under the monthly distribution frequency will be the **15**th **day of January 2024**. The record dates under the monthly distribution frequency are intended to be the 15th day of each month (or the next Business Day if that day is not a Business Day) or such other date as the Manager may in its absolute discretion determine.

In connection with the change in distribution frequency, we would also like to inform you that, with effect from **8 January 2024**, the existing "-QDis" distribution and decumulation classes of units in the Sub-Fund will be re-designated as "-MDis" as shown below:

We wish to assure you that other than the change in distribution frequency, and the re-designation of the existing "-QDis" distribution and decumulation classes of units to "-MDis" respectively (which in this case is essentially a change in the naming convention of the units that you hold in the Sub-Fund), nothing else has changed in respect of your holdings, the terms of your holdings, and your rights and entitlements in relation to your holdings. The investment objective, focus and approach of the Sub-Fund also remain unchanged.
