Manulife Empower Conservative Fund

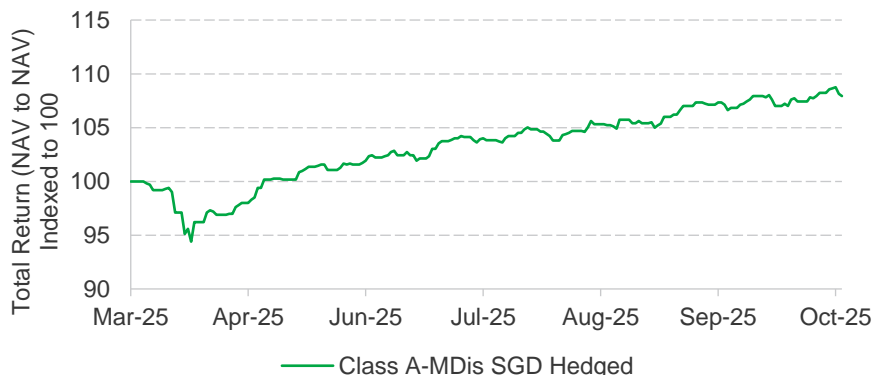
Investment Objective
